EUDR INFORMATION SYSTEM (IS): TRACES NT

EUDR IS and DDD content management

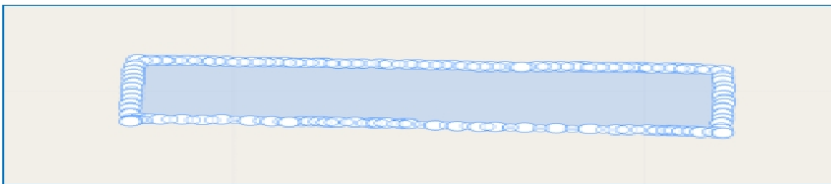
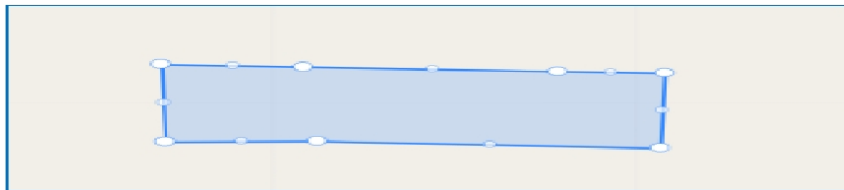
FAQ 7.12, 7.16, 7.23 : amount of information contained in a DDD:

A DDD can :

- refer to 2000 DDR upstream,
- include up to 200 lines of product description, 500 lines for commodity names (species), and 1000 lines for production sites.

The size of the DDD must not exceed 25 MB, which corresponds to more than one million geolocation points; beyond that, the number of coordinates describing the polygons must be reduced to lighten the DDD.

No possibility of including attachments other than the download of geolocation data.



EUDR IS and DDD content management

FAQ 7.4 Possibility of duplicating a previous DDD: avoids re-entering data reusable or recurring information.

FAQ 7.6 Withdrawal or modification of an DDD is authorised within 72 hours of submission, unless the DDD is placed under control by the competent authority.

EUDR IS and DDD content management

FAQ 7.20 : When exporting to different countries, it is not necessary to create an DDD for each country of destination, as this information does not have to appear in the DDD.

=FAQ 7.22 : The net mass to be entered is that of the whole product excluding packaging, even if only part of it consists of a product covered by the EUDR.


FAQ 7.28 : When the operator refers to another DDD in his own DDD, certain data such as the scientific name of the wood products are automatically loaded into the new DDD.

FAQ 7.25 When a downstream operator/trader receives DDD reference and verification numbers from an upstream operator/trader, it can check their validity via the information system.

EUDR IS and access to DDD

FAQ 5.2.1 and 7.29


Account management: a user may have several roles (operator, merchant, agent) in the information system: they must specify the status under which they carry out each DDD.


