Against the light of the European Timber Regulation (EUTR) that requires importers to operate a Due Diligence System which should ensure that illegally harvested timber is eliminated from the supply chain, and in order to facilitate sustainable timber trade between EU countries and timber producing countries, since 2016 Form International is coordinator and implementor of the Timber Trade Portal.

Launched originally as an European Timber Trade Federation (ETTF) project and currently jointly owned by the ETTF and the Association Technique Internationale des Bois Tropicaux (ATIBT) this web portal is a 'one-stop' information point on timber industry and legality information.

It serves as a central information point, where visitors can find country profiles on both timber industry and legislation of timber producer

countries, mainly located in tropical Africa, Asia and Latin America.

The content of a country profile exists of the following elements:

- Forest resources and structure of forestry sector
- Production and export, production and trade data
- Legislative framework, laws and regulations
- Key documents required to trade legally
- Timber species bans & quota
- CITES and protected species
- National action on timber legality verification (e.g. VPA)
